BLEDLOW-CUM-SAUNDERTON PARISH COUNCIL

Minutes of the Parish Council Meeting held in Bledlow Village Hall on Thursday, 7th March 2013

Present: Cllrs. Mrs. Butler, Breese (Chairman), Cox, Ms. Hojer, Reading, Mrs. Stallwood, Stone, and Mrs. Taylor.

Minutes of the last Meeting

The minutes of the meeting held on 7th February 2013 were approved after a proposal by Cllr. Hojer seconded by Cllr. Reading, and were signed by the Chairman as a true record.

Matters Arising

Road Maintenance and Traffic Calming

The Chairman made the suggestion that, in view of the continuing poor condition of local roads, each member of the Parish Council be allocated an area to monitor and make subsequent reports of potholes to TfB.

Allocations were agreed as follow:

West Lane, Perry Lane, Bledlow Ridge Road, Wigans Lane. Cllr. Breese.

B4009, Sandpit Lane, North Mill Road, Cllrs. Britnell and Stone.

Upper Icknield Way, Lee Road, A4010. Cllr. Reading

Chinnor Road Bledlow Ridge, Haw Lane. Cllrs. Butler, Cox and Hojer.

County Cllr. Rogerson had confirmed that the resurfacing of the bottom section of Haw Lane is now in TfB's schedule, as are Sandpit lane and North Mill Road. He had also said that the flooding of the B4009 on the Longwick side of the S bends is being kept under observation.

Churchyard Trees

A report conducted by Four Seasons Tree Care on the condition of the trees in Holy Trinity churchyard had been circulated prior to the meeting. The report contained details of suggested tree surgery with a view to ensuring the trees' safety and continuing good condition. Mr. Keith MacGregor had quoted for a full arboricultural survey and report at a cost of £1250.

After discussion of the merits of Four Seasons report it was agreed to accept its findings, and the Clerk was asked to obtain quotes to do the work specified in it. He was also asked to get estimates of the life expectancy of the three species involved, and to ensure that the Churchwarden was given a copy of the report. The Clerk was also asked to email the Churchwarden telling him of the Council's proposal and the likely life expectancy of the trees.

Internet and Website

In his absence, the Chairman read out Cllr. Britnell's summary of progress so far in the campaign for faster broadband. About 120 people have so far registered their interest on the Bucks CC website out of 350 mailings to local email addresses. Twenty five people have so far indicated their interest in being include for links to the yet-to-be-developed Parish Council website.

The Chairman told the meeting that he is still communicating with Mr. Adams about developing the website, and that a test website was said to be in existence.

Saunderton Civil Burial Ground

The Clerk told the meeting that the civil burial ground in Saunderton churchyard now had only seven vacant plots available and, at the historic rate of take-up, these would be gone within two to three years. The Clerk was asked to write to the church warden on the matter, so that the PCC could be updated and alerted to the need for additional consecrated burial space.

In an associated discussion, the meeting agreed with a proposal by Cllr. Reading, seconded by Cllr. Mrs. Butler, to raise the burial fee to £100.
