Road Repairs/Traffic Calming

The Clerk gave an update on what he understands to be the most recent appraisal of repairs of the 30mph limit.

There is considerable concern about the state of other roads in the Parish, and Cllr. Cox volunteered to conduct a survey and compile a report.

The flooding in the dip in Haw Lane is still occurring despite BCC having claimed to have Cllr. Uglow said that the Bledlow speed control scheme is not on the agenda for the next LAF meeting, which either Cllr. Breese or Cllr. Stone would attend.

6. Sundry Parish Matters

Rose & Crown

The Clerk was asked to contact the firm involved to point out that the quotation could not be followed up by the Council as it has no jurisdiction over the land in question.

The matter of a grant of money received by the Parish Council specifically for Meadow Stiles playground was discussed in this context, and it was agreed that the grant could not be used for the proposed Bike Activity park.
