# Minutes of the Parish Council Meeting held in Bledlow Ridge Village Hall on Thursday, 5<sup>th</sup> June 2014

#### Minutes of the last Meeting

The minutes of the meeting held on 1<sup>st</sup> Mayl 2014 were approved and signed as a true record following a proposal by Cllr. Britnell seconded by Cllr. Butler.

## **Matters Arising**

#### Roads

The Clerk would report the poor condition of Horsenden Lane to TfB.

It has been confirmed that the lower section of Haw Lane will be surface-dressed at an as yet undisclosed date.

The Bledlow Ridge VASs have not yet been installed, but it is expected that the work will be done before the end of June. Both Cllr. Cox and the Clerk praised the efforts of the TfB technician, Shane Thomas.

Cllr. Reading reported that wild orchids in the verge at the junction of Shootacre Lane and Upper Icknield Way had been cut down when contractors had mown the grass verge. County Cllr. Etholen would report the matter.

# Children's Playgrounds

As arranged at the last meeting ClIr. Stallwood had examined the accounting and documentary records held by the Clerk and by Mrs. Smith. The preliminary finding is that the FSA grant of £25000 had been much reduced by spending to date. In ClIr. Stallwood's absence, further discussion of the matter was deferred until the next meeting.

The Chairman invited Cllr. Britnell to put forward his suggestion that the Parish Council adopt full responsibility for the playground at Bledlow Village Hall.

The Chairman said that, in his view, the Parish Council should have no playground responsibilities beyond making occasional grants to responsible and formally constituted bodies trusted with their upkeep and maintenance.

In view of the almost nine years left on the Meadow Stiles lease, the question remains of how to implement such an arms-length policy. Cllr. Britnell volunteered to formulate a policy statement for this concept.

In the meantime, a quotation had been received for the repair of the Meadow Stiles dish roundabout and replacement of two swing seats. The cost before VAT is £1089.

The meeting considered that the cost was too high and further quotes would be sought. It was agreed, however, that the swing seats should be purchased, with the work of installing them left to local labour.

The Clerk was asked to research sources of grant aid for playgrounds, and County Cllr. Etholen suggested that the Local Area Forum also be approached.
