#### **Localism Act - WDC Code of Conduct**

The meeting noted with satisfaction that the new owners of the site and commenced work on making the listed building safe and weatherproof.

# **Holy Trinity Churchyard**

The Clerk said that he had received complaints from the new churchwarden about the grass clippings left behind after John Lawrence had cut it. The Clerk reminded the meeting that the Parish Council has a statutory duty to maintain the closed churchyard and, in common with other grass cutting in the Parish, the contract wiith Mr. Lawrence is on a 'cut and no collect' basis. The meeting agreed that the Clerk should obtain a quote from Mr. Lawrence for collecting the grass and taking it away, after which the Parish Council would decide how best to deal with the matter.
