BLEDLOW-CUM-SAUNDERTON PARISH COUNCIL

Minutes of the Parish Council Meeting held in Bledlow Village Hall on Thursday, 4th September 2014

Present: Cllrs Britnell, Breese (Chairman), Butler, Cox, Hojer, Reading, Stallwood, Stone, Taylor and County Cllr. Etholen.

Minutes of the last Meeting

The minutes of the meeting held on 7th August 2014 were approved and signed by the Chairman as a true record.

Proposed Touring Caravan Site

In view of the large number of members of the public in attendance wanting to hear the meeting deal with this matter, the Chairman invited Mr. Phil Bailey to address the meeting on their behalf.

Mr. Bailey told the meeting that most if not all Chapel Lane residents are vehemently opposed to the Caravan Club's proposal to locate a touring caravan site on a field near the end of the Lane. He cited a number of reasons for objection including the likelihood of flooding on the proposed site, poor access down Chapel Lane and into the field in question, and the likelihood of there being no on-site or nearby supervision .

The Parish Council was urged to send a letter of objection to the Caravan Club which, after little further debate, the meeting agreed to do. The Chairman said that in anticipation of the decision, a letter had been drafted and would be sent to the Caravan Club next day after suitable amendments had been made.

Another resident, Mr. Jeffery, made reference to Article 4 of the 1936 Public Health Act, which can invoke prohibitions on certain activities on sites such as the one in question.

Mr. Jeffery said that he would do further work on this matter and provide the Clerk with a suggested draft letter to WDC, BCC and David Lidington, MP.

Community First Responders

Mr. Marc Lister was invited to speak about getting people in the parish to volunteer to become Community First Responders primarily to be able to operate defibrillation machines. The machines can be made available by South Central Ambulance Service, at cost, for siting at suitable locations, such as village halls. Mr. Lister was first seeking volunteers and the meeting agreed that the Clerk should place an item in the two local newsletters. Cllr. Cox also suggested that Mr. Lister should contact Mrs. Smith, who is a highly qualified nurse living in Bledlow Ridge. The Clerk agreed to let Mr. Lister have Mrs. Smith's contact details.

Matters Arising from the Minutes

Verge Cutting

The Clerk said that he had attended a meeting in Princes Risborough concerning the devolution of certain work now done by BCC to town and parish councils. It became obvious that the quotation he had been asked to get from Mr. Brooks for cutting roadside verges had been based on a mistaken assumption, and that devolution of verge-cutting would be confined to roadsides within 30mph limits, with some exceptions within 40mph limits.

Other devolved work included hedge cutting, and road sign cleaning.

Princes Risborough Town Council (PRTC)would act as the 'hub' contractor and individual parish councils would delegate the wok to them, spending their allocation of the devolved budget as they saw fit.

County Cllr. Etholen further expanded on the potential benefits of the project and, following the Clerk's recommendation that the Parish Council take part on a pilot basis for a maximum of one year, the meeting agreed that the Clerk give PRTC the go-ahead for a one-year trial.

Meadow Stiles Finances

Cllr. Stallwood had produced a schedule of income and expenditure since the Playground was recommissioned in 2005. It was agreed, before reviewing the data, that a sub-committee consisting of Cllrs. Stallwood, Butler, Hojer and Reading should convene to draw up a proposed policy statement for the Playground to stipulate future responsibilities and expenditure, and to present their findings to the next Parish Council meeting. Cllr. Reading further agreed to draft a memo of understanding for the Playground.

After some debate, Cllr. Reading proposed that a one-off grant of £600 be provided. The proposal was seconded by Cllr. Stone and adopted.
