# Minutes of the Parish Council Meeting held in Bledlow Ridge Village Hall on Thursday, 6<sup>th</sup> December 2013

## **Risborough Area Community Bus**

The Chairman invited Mr. Peter Johnson to address the meeting. Mr. Johnson said that the service had started in 2010 and now carries about 400 passengers a week over its six routes, has 30 drivers and also arranges outings to local places of interest. The bus may also be hired by groups.

Talking about the Bledlows route in particular, Mr. Johnson said that only about 50 people regularly used the service each month in a catchment area with an adult population of nearly 2000. The service needs to be publicised in Bledlow, Bledlow Ridge and Saunderton. Both local parish magazines had carried an item submitted by the Clerk last month outlining the service with an accompanying timetable. It was suggested to Mr. Johnson that he contact the editors of the newsletters and ask that they include a more comprehensive overview of the service. The Clerk would provide the contact details.

Mr. Johnson then asked the meeting to consider making a grant towards the cost of a new bus to replace the existing vehicle, which would be ready for retirement within five years.

The Chairman asked how much, for example, Princes Risborough Town Council contributed and Mr. Johnson quoted £1000. The meeting agreed with the Chairman that a grant would almost certainly be forthcoming, but that the Parish Council would prefer to wait to see how well Mr. Johnson's newsletter items succeeded in bringing in more passengers before coming to a decision. In the meantime, the Parish Council would ensure that service timetables are posted on its noticeboards.

## Minutes of the last Meeting

The minutes of the meeting held on 7<sup>th</sup> November 2013 were signed as a true record following a proposal by Cllr. Butler seconded by Cllr. Hojer.

## **Matters Arising**

#### Solar Farm

The Clerk confirmed that there had been no further news of progress on Hive's submitting a planning application.

## Traffic Calming/Road Maintenance

The Clerk said that BCC had been paid the £5000 pledged contribution to the cost of the VASs in Bledlow. The payment had been accompanied by a letter to explain that the Parish Council remains dissatisfied with the location of the VAS on the Chinnor side of the S bends.

There had been arbitrated agreement on the siting of the proposed VASs in Chinnor Road, Bledlow Ridge and that TfB had been notified of the Parish Council's decision.

Work had been done to the drain outside Queens Cottages in Bledlow, and road resurfacing on the same stretch of the B4009 is due to be carried out between that 5<sup>th</sup> and 9<sup>th</sup> December. A view on the effectiveness of the culvert work will only be possible after the next heavy downpour.

The Clerk would report a large pothole in Chinnor Road, Bledlow Ridge near Routs Green.

Cllr. Stallwood said that a number of temporary road works signs had been left in Haw lane following the resurfacing work in September. County Cllr. Etholen said that he would take the matter up with the Local Area Technician.

## Studmore Pond

The Clerk said that he had accepted a quote of £1340 plus VAT from Four Seasons Tree Care to carry out the necessary tree surgery in Studmore Pond. The work has been scheduled for 24<sup>th</sup> January.

## **Applications for Grants**

Mrs. Susanne Smith gave a presentation to the meeting of her attempt to obtain a grant from the Parish Council to fund the proposed advertising sign for the Bledlow Ridge Village Stores.

The total cost of the sign and its installation would be £650 plus VAT and, after some discussion about how much to grant, Cllr. Reading proposed that the Council contribute the full cost, a proposal seconded by Cllr. Butler. A counter proposal of £500 was made by Cllr. Stallwood, but not seconded.

The meeting then voted on Cllr. Reading's proposal, which was agreed unanimously. The Chairman asked Mrs. Smith to have the invoice made out to the Parish Council and sent to the Clerk.
