Minutes of the Parish Council Meeting held at Bledlow Ridge Village Hall on Monday 11th December 2023

- 113. To receive apologies for absence: Cllr Breese (Chairman). Buckinghamshire Councillor: R Carington
- **114. Declaration of Interests and Dispensations:** None declared.
- **115.** To approve minutes of the Parish Council meeting held on the 13th November 2023: A vote was taken and all Councillors were in favour and the minutes were signed.
- 116. To receive an update from Buckinghamshire Councillors, responses to outstanding actions and to receive questions from Parish Councillors:
 - a. Bledlow Ridge Household Recycling Centre, Wigans Lane, Bledlow Ridge: Stats on tonnage had been received and circulated. The question was asked as to whether there were any stats on revenue received from users outside of Buckinghamshire. Buckinghamshire Councillors will investigate whether this data is available.

- The Parish Council had also received a complaint for not checking of identification. This was raised with Buckinghamshire Councillor and the contractors onsite spoken too.
- Cllr Cox stated that the flood lights had been left on a few times recently. Buckinghamshire Councillors will feed this back to the relevant Officers.
- b. Princes Risborough Relief Road Culverton Link and Proposed Village Green: Cllr Bird stated that there will be an enquiry for the Village Green in the New Year.
 Culverton Link: Cllr Etholen stated that there was supposed to be a meeting on 23rd October 23 but

unsure whether this took place but will make enquiries.

- c. The Paddocks Enforcement Update on Caravan / Mobile Home: Cllr Etholen stated that the owners have 12 months to complete the works and remove the temporary structure.
 Cllr Carington had an action from last months meeting to enquire when the 12 months commences from.

- **d.** Traffic Calming: Cllr Reading reported that he heard from the Buckinghamshire Council Officer but following this has had no further communication.
- **e.** Cllr Reading thanked Cllr Carington for his prompt response to the planning application at the former Molins site 22/06872/VCDN. The planning decision will be discussed later in the meeting.

It was confirmed that the ownership had not yet been transferred and works will be commencing in February 2024.

Discussions were had on The White House where it appears work is being carried out without permission. There had previously been a Temporary Stop Notice issued but this ceased around September 23. This had been reported to the Enforcement Team at Buckinghamshire Council.

- 119. Neighbourhood Plan Update: A meeting of the Working Group has been arranged for a week's time.
- 120. Correspondence, reports and issues from Councillors and Clerk:
 - a. Cllr Bridgman has attended the Planning Demystified training and will circulate notes to Councillors.
 - b. Cllr Bridgman reported that the Chiltern Society have received approval to recreate Bledlow Cross. Works will start in March 2024 with the works being carried out by a working party.
 - c. Cllr Bird shared a map with Councillors showing a footpath which the Parish Council would like at the bottom of Lodge Hill and had been discussed previously under item 109. Cllr Bird asked Councillors to consider whether this is something the Parish Council would like to pursue.
 - d. Cllr Reading had spoken to a Bledlow residents regarding speed of vehicles in Sandpit Lane. As it's a National Speed Limit area Cllr Reading informed him it would be unlikely that the speed could be reduced but would discuss with the Parish Council and also the transport committee of the Community Board as to the process of getting speeds reduced.
 - e. Cllr Reading reported that the café at Bledlow Ridge Cricket Club is closing and there is a meeting in place to discuss its future on Saturday 16th December. Cllr Butler suggested the Community Ownership Funding. It was agreed to wait and see what the outcome of the meeting is.
 - f. Cllr Cox raised a concern with fly tipping on the footpath by Meadow Styles and entrance to Stud Farm in Bledlow Ridge. It was agreed that this should be reported on FixMyStreet by the resident who reported it.
 - g. Cllr Cox stated that the hedges and verge have been cut at the top of Radnage Lane.
 - h. The Clerk reported that money had now been transferred from the NS&I account into the Unity Account and the NS&I account has now been closed.


